Option 1

- Tournament coordinated by USSSA Eastern PA/New Jersey staff.
- Tournament directed by USSSA Eastern PA/New Jersey staff.
- Trophies provided by USSSA Eastern PA/New Jersey.
- Umpires and UIC paid for by USSSA Eastern PA/New Jersey.
- Balls Provided by USSSA Eastern PA/New Jersey.
- Clothing & Souvenir sales provided by USSSA Eastern PA/New Jersey.
- If required, hotel rooms for umpires provided by USSSA Eastern PA/New Jersey.
- Host organization provides food stand, keeps all profits.
- USSSA Eastern PA/New Jersey pays host organization \$75.00 per field per weekend for a completed tournament for field grooming* during the weekend.
- Host organization secures permits for the fields, any field rental fees must be submitted to USSSA Eastern PA/New Jersey for approval.
- Pool schedule, Pool play results, Sunday brackets and tournament results posted on USSSA website.
- "Host" team will receive a berth to the USSSA World Series "A" or "B" to be determined by USSSA Fastpitch director and team manager.
- "Memo of Understanding" outlining above to be completed and signed by host team.

Option 2

- Tournament coordinated and directed by host team. All registrations by teams must be done via the USSSA Eastern PA/New Jersey website**
- Host team pays USSSA Eastern PA/New Jersey \$75.0 sanction fee per tournament.
- Host team pays USSSA Eastern PA/New Jersey \$20.00 per team.
- Trophies provided by hosting team.
- Balls provided by host team. Must be USSSA approved balls. Balls are available through USSSA youth office at a discounted price of \$45.00 per dozen.
- Clothing & Souvenir sales provided by USSSA Eastern PA/New Jersey.
- If required, Port-a-potties provided by host team.
- If required, umpire hotel fees paid for by Host team
- Host organization provides food stand.
- Tournament Schedule, Saturday results, Sunday brackets and tournament results posted must be scheduled and distributed from USSSA Eastern PA/New Jersey website.**
- Host team grooms* fields.
- "Host" team will receive a berth to the USSSA World Series "A" or "B" to be determined by USSSA Fastpitch director and team manager.
- "Memo of Understanding" outlining above to be completed and signed by host team.

- Option 2, Turface provided by Host team

- All teams and tournament scheduling must be done on the USSSA website. Host team to identify key individual to handle this activity.
- Training for use of website will be provided by USSSA State Fastpitch Director.
- USSSA Eastern PA/NJ will handle scheduling, posting of Sunday schedule and posting final results for a fee negotiated with the host team.
